DISCUSSION/ACTION AGENDA:

*** EMERGENCY RESOLUTION- HS ROOF**

- Last winter, the high school had water leakage in the band room and after further investigation it was determined that the leak was coming from the roof. We have also experienced similar leaking in the concessions area and weight room of the high school. The leaks have gotten worse as the year progressed. The significant snow fall last winter and rain in the spring have shown these areas of the high school to experience safety concerns for all students and staff.

Mr. Dey moved and Mr. Seitz seconded to approve to authorize the superintendent to take necessary action to repair the affected facilities in accordance with Section 20-9-204(3), MCA and approve the Emergency Resolution to hire Thiel Bros to repair the above named sections of the high school roof. Discussion on bids from Thiel Bros Roofing. Motion passed 7 to 0.

Mr. Villegas moved with a second from Mr. Marker to approve the 75 mill roof for HS Band room. The motion passed 7 – 0.

Ms. Dey moved and Mr. Marker seconded to approve 75 mill room for the HS Concession Stand and Locker Room. The motion passed 7 – 0.
